*(Each customer is limited to one room air purifier rebate per calendar year.)*
- Application must be submitted within 45 days from purchase date or by January 15 of the following calendar year, whichever comes first.

# Appalachian Power \$50 Rebate

Get \$50 back from Appalachian Power on your purchase of a current ENERGY STAR certified room air purifier. This rebate is good for purchases made 1/1/22 through 12/31/23. Limit one rebate per residential electric account per calendar year. Funding for this program is limited.

Please include a copy of your dated sales receipt and/or invoice from a retailer showing the manufacturer, model number and price of the ENERGY STAR certified room air purifiers purchased. Incomplete information will delay or disqualify your rebate. All rebate requests must be postmarked no later than January 15 of the year following your purchase. ## Did You Know?

A standard room air purifier, operating continuously, uses approximately 550 kWh per year in electricity. This is more than the energy used by some new refrigerators!
